



## **POWRi Quarter Midget Racing League Club Charters Procedure**

### **General**

Membership shall be open only to individuals or clubs desiring to further the purpose of POWRi Quarter Midget Racing.

### **Charter Application**

Application for a POWRi QMRL Club Charter Membership; the club must be made by a group of at least five (5) members, signing a written application along with Club bylaws and all club rules addressed to POWRi Racing Inc. The club will agree to a one-year commitment by signing the Charter.

### **Approval**

Unless otherwise ordered by POWRi, approval of a club charter application shall be effective on the date at which the issuance of the charter is authorized, and the club charter shall bear that date. The names of the charter members appearing on the charter shall be in alphabetical order without rank or title.

### **Removal**

Such charter may be revoked, withdrawn, or suspended by POWRi, when in its judgment; continuation of such club is not in the best interest of POWRi.

### **Club Directors**

Each club shall be presided over by its President, who shall be assisted by a Vice President, a Secretary, a Treasurer, a Technical Director, a Safety Director, and a Publicity Director. Additional Directors are optional with each club. These club officers and others shall be elected as prescribed in the club Bylaws.

### **Membership Year (Association Fee and Local Club Fees)**

A club may induct invitees into membership in POWRI, in the manner prescribed by the Bylaws of the club or as delegated by the Board of Directors. However, such membership shall be contingent upon fulfillment of all obligations to POWRI. There are two types of memberships that are recognized:

**Regular Member**- Defined as a legal guardian (husband, wife or couple) and all drivers/non-drivers under the age of 21 years of age of that immediate family that live in the same household. The members constituting one hundred percent (100%) of the voting power of this corporation shall be known as the Regular membership. These members also have full racing privileges and their POWRI dues are payable through ONLINE membership application.

**Alternate Member** - Defined as a single person that has no drivers. Alternate Handlers are not included in the Regular/Family membership and shall have no right to vote, they are covered under the provided insurance. POWRI dues are payable through ONLINE membership application.

**Associate Member** - Associate membership are members that are currently paid POWRI member that wishes to join another POWRI track. Associate membership must pay club membership fee (local level only).

### **Period of Membership**

The membership year is from January 1 to December 31 each year, with dues payable in advance from September 1 to December 31 of the preceding year. Membership applications not received by POWRI by January 1 each year will cause the individual membership with POWRI to be suspended until paid.

### **Meetings**

#### **Annual**

The annual meeting / conference call of POWRI shall be held each year at such time and place and shall be designated by POWRI. Notifications of the time and place shall not be less than 90 days prior to the meeting.

#### **Representation**

Each Club may be represented by its Club President or their delegate at any annual meeting or special meeting of POWRI.
